

What is *Faith in Action*?

Faith in Action, a program founded by The Robert Wood Johnson Foundation, is a nationwide network of interfaith volunteer caregiving programs. These programs bring together volunteers of many different faiths to help people who have long-term health conditions to enhance their quality of life by providing assistance with daily activities.

Faith in Action has more than 650 programs nationwide, including 32 programs in Illinois.

Faith in Action volunteer activities may include shopping for groceries, providing rides to medical or other appointments, cooking meals, doing light housework, running errands or providing companionship through visiting or phoning. Volunteers may also provide respite care and relief for family caregivers. With the assistance of volunteers, community members with long-term health needs maintain their independence for as long as possible.

Faith in Action programs provide caring assistance at no cost to people living in their community. Each program site is unique in the population served and services provided. Please contact the *Faith in Action* site nearest you for specific information. (See 2008 listings on reverse side.)
